Created the strategy to monitor all legislative and policy activity related to the 2005 BRAC law for impact to Arlington and the region. Advised County Board, County Manager, Economic Development Commission and Economic Development Director of potential effects from activity, offering scenarios of affect and response.

Administered all aspects of the Arlington County BRAC Project that directed action on thirty-four strategic recommendations owned by several County departments, including economic development, workforce development, transportation, planning, environmental services, and parks and recreation. Initiated a comprehensive workplan that identified, prioritized and assigned specific projects and tasks required to fully implement the BRAC recommendations. Projects and tasks included economic impact studies, retail studies, transportation/transit studies, community forums and monitoring state and federal legislative and policy activity. Coordinated with task owners to ensure all resources were in place to carry out functions. Formulated policies that directed daily workforce development aspects of the Arlington BRAC project with the goal of sustaining Arlington's workforce strength through the transition. Directed the work of six workforce and economic development staff as we conducted research and created a profile of the BRAC'd worker citing the numbers and types of positions and occupation descriptions using Standard Occupational Classifications (SOC) codes, Northern American Industry Classification System (NAICS) codes, and Military Occupational Specialties (MOS) codes, commuting patterns, security clearances, salary ranges and impending retirements. Additionally, determined education and training needs of workforce through collaborations with Department of Defense (DoD) HR staff. Collaborations helped create programming and an operation plan to respond to identified needs of workers for service delivery at the BRAC Transition Center. Programming had regional impact as it served impacted workers in the National Capital Region, helping to retain the competitive advantage of the region to attract business requiring cleared, skilled workers.

COMMUNICATION AND FACILITATION

AUTHOR

Co-authored two articles on the 2005 BRAC decision and authored two articles on Arlington as a model for building resiliency. The BRAC articles cite the unprecedented impact on commercial space in Arlington and Alexandria. They speak to the anticipated economic, workforce and business impacts, as well as the deliberate efforts toward partnerships and recovery and expansion leading to corridors of economic activity. The two resiliency articles discuss how Arlington uses the Living Laboratory environment to test, analyze and evaluate policy challenges and mitigations and how it uses the skilled workforce as a tool for building a resilient business market. I also wrote a monthly column and provided updates on thirteen BRAC actions for the Arlington BRAC Newsletter.
